PUBLIC COMMENT:

- The Center for Data Insights and Innovation (CDII) provided public notice of intended administrative modifications to the following Policies and Procedures (P&Ps) to transition administration of DxF to the California Department of Health Care Access and Information (HCAI). Objections to the modification as administrative are due no later than 8am PT Tuesday, September 2, 2025.

- As such, CDII is seeking public comment ***only with respect to these proposed administrative modifications*** and is facilitating public comment through a simplified process and [form](#). HCAI will complete the modification process following closure of the objection period.

2025 STANDARDS COMMITTEE:

- HCAI does not anticipate convening a Standards Committee to discuss potential technical standards advancement in 2025.
- See the Data Elements to Be Exchanged P&P v1.2 already amended to update the version of USCDI required for exchange by DxF Participants effective January 1, 2026.
- Watch for upcoming finalization of the proposed amendment to the Technical Requirements for Exchange P&P and its proposed advancement of technical standards for Event Notification.
