# **DxF Updates**

#### SB 660 Signed Into Law

- Background: SB 660 has been passed by the legislature and signed by Governor Gavin Newsom. The legislation expands the DxF by establishing new provisions for transparency and accountability, while also strengthening the program's stakeholder governance.

### **DSA Signatory Grants**

- As of October 31, 2025, the DxF Program has disbursed a total of \$28,400,875 to Grantees for Milestone 1 and 2 achievements.

 As a reminder, the <u>Data Elements to Be Exchanged P&P v1.2</u> has been amended to update USCDI requirements to version 3 effective January 1, 2026, as recommended by the 2024 Standards Committee and to align with federal health IT certification requirements.
